10:00am - Race start for 1st heat - \*20 (4-6 dog), \*40 (6-8 dog), \*60 (10-12 dog) mile races.

12:00pm to 2:00pm - Teams arrive at finish line.

2:00pm - Skijoring race start: Advanced 4 mile (1-2 dog) Novice 2 mile (1-2 dog).

### Sunday, March 11

9:00am - Race start for 2nd heat - \*20, \*40, \*60 mile races. Reverse start order - slowest teams first.

10:00am to 12:00pm - Teams arrive at finish line.
